There was increased Technical Official travel numbers because there were more non-Townsville based club people getting interested which is fantastic with more technical officials being available in the region.</li> <li>As per the profit and loss the gross profit was \$71,384.61 and the operating expenses were \$63,488.19 which was up by about \$7,000 for the income.</li> <li>Apart from the extra income from the extras meets it was a pretty standard year</li> </ul>
